2019-20 Provisional Member Agreement

All current policies or standing rules pertaining to Provisionals are stated in the following agreement.

I, _____, accept the invitation for Provisional membership to the Junior League of Abilene, Inc. and will participate in the 2019-20 Provisional Course.

I. LEAGUE OBLIGATIONS

The Junior League of Abilene, Inc. will:

- A. Create and conduct a Provisional training course.
- B. Educate the Provisional in the administrative process of the Junior League on a local and regional level.
- C. Educate the Provisional about the community of Abilene.
- D. Provide opportunities for a variety of training experiences.

II. FINANCIAL OBLIGATIONS FOR PROVISIONAL MEMBERSHIP

- A. I will pay Provisional Course dues of \$188 (\$50 upon acceptance of the invitation to be a provisional member, and no later than July 31, 2019) on or before May 1, 2020.
- B. I will pay a Money Raising Obligation (MRO) of at least \$100 to Christmas Carousel — an annual event benefiting League projects.
- C. I will pay annual dues of \$138 (\$42 Meeting Assessment, \$96 dues) or enroll in a payment plan no later than June 30, 2020.
- D. If I present a financial hardship, I know to contact the New Member Chairman to request scholarship assistance.

III. MEMBERSHIP REQUIREMENTS

To become an Active member in the Junior League of Abilene, Inc., I must:

- A. Attend 6 of 8 monthly Provisional meetings.
- B. Fulfill all credit requirements determined by the Board for projects, fundraisers, and committee placements.
- C. Understand that requirements are subject to change with advance notice.

IV. OTHER ACKNOWLEDGEMENTS

- A. Satisfactory completion of the above obligations and requirements is required for acceptance to Active membership.
- B. A Provisional who is current in her obligations and who anticipates her inability to complete the Provisional course may resign and be reinstated at ANY time.
- C. A Provisional who accepts an invitation and then resigns at any time during the Provisional course must take the complete Provisional course after her reinstatement.
- D. To become a sustaining member in the Junior League of Abilene, I must be an Active member in good standing for a minimum of seven years.
- E. This invitation to Provisional Membership is revoked if I do not agree to the terms above, sign this Provisional Agreement, and meet the Financial Obligations for Provisional membership by July 31, 2019.
